Typical Inductance vs. Frequency Characteristics:



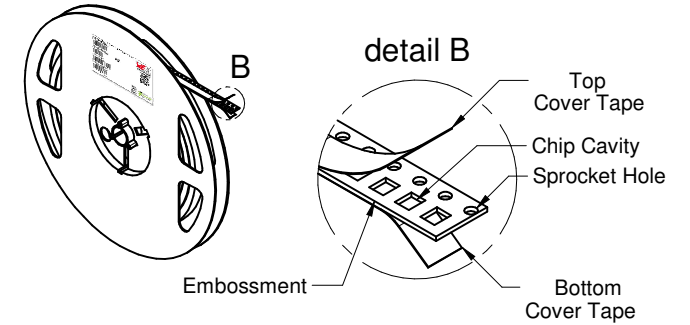
Q-Factor vs. Frequency:

Soldering:

Cleaning and Washing:



Storage Conditions:


