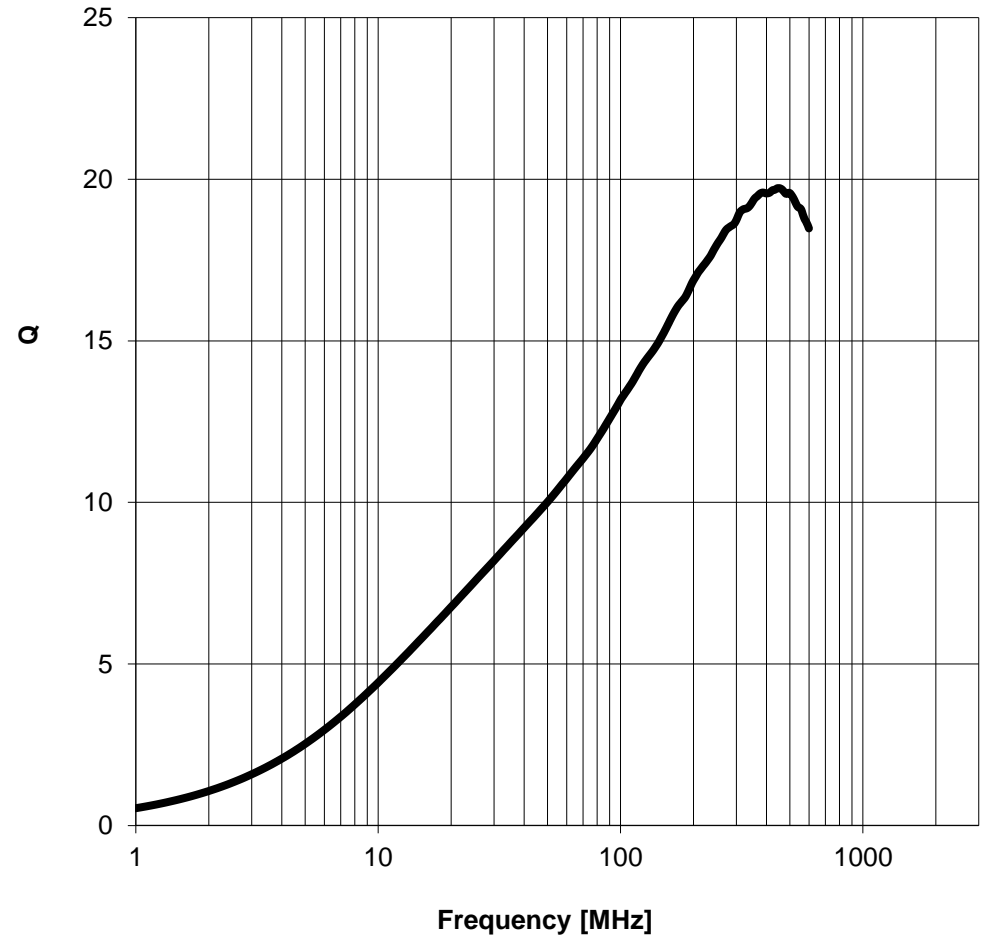



Storage Conditions:


