### Typical Inductance vs. Frequency Characteristics:



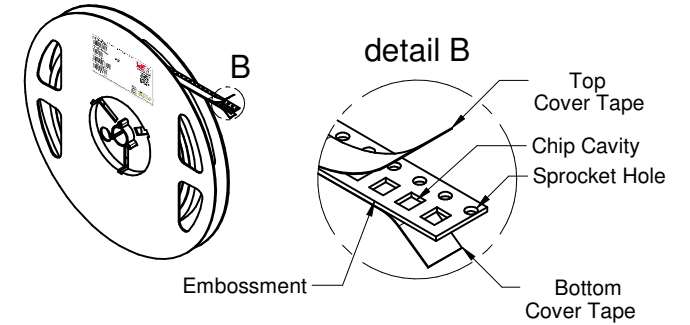
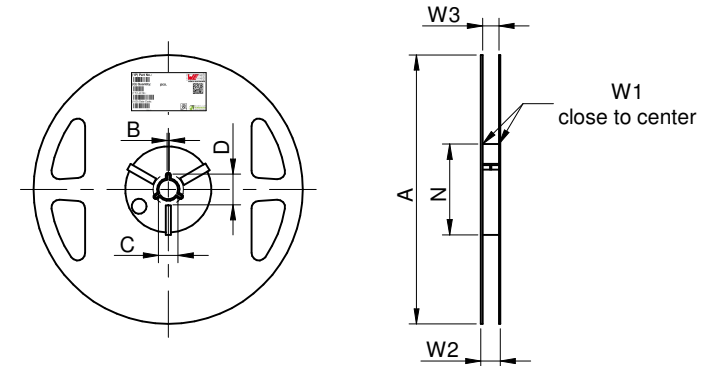
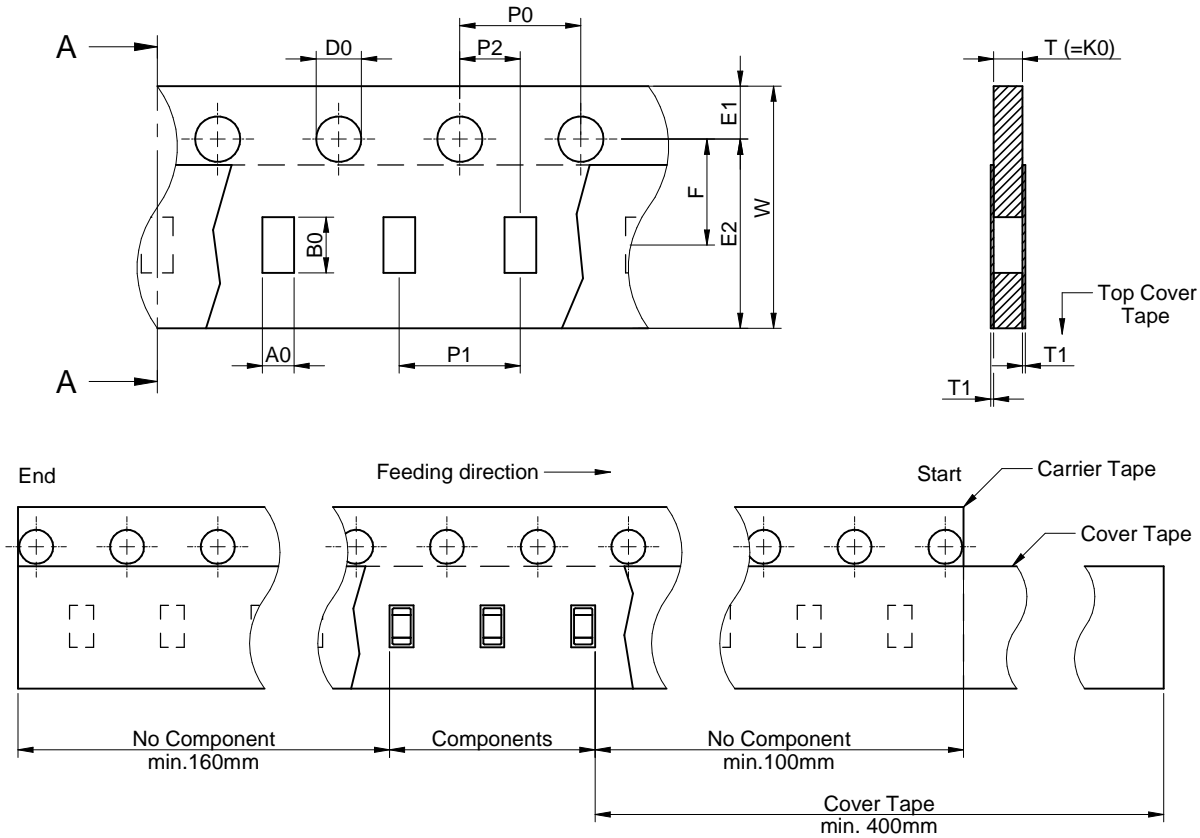
### Q-Factor vs. Frequency:

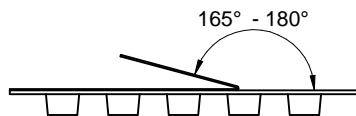



## Storage Conditions:


