Q-Factor vs. Frequency:

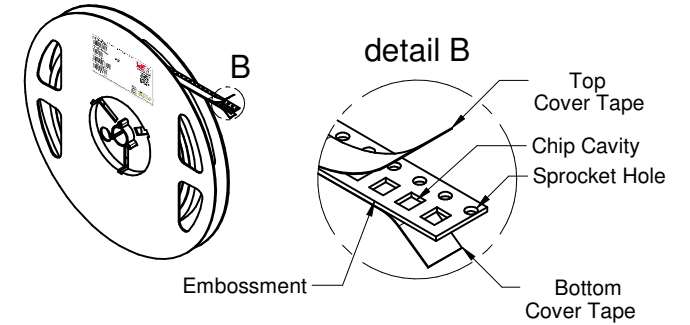
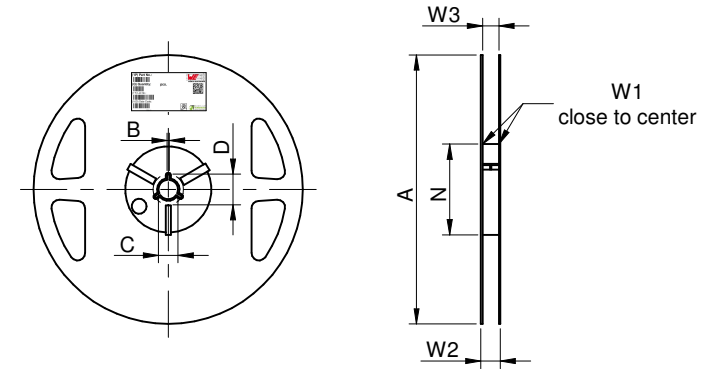
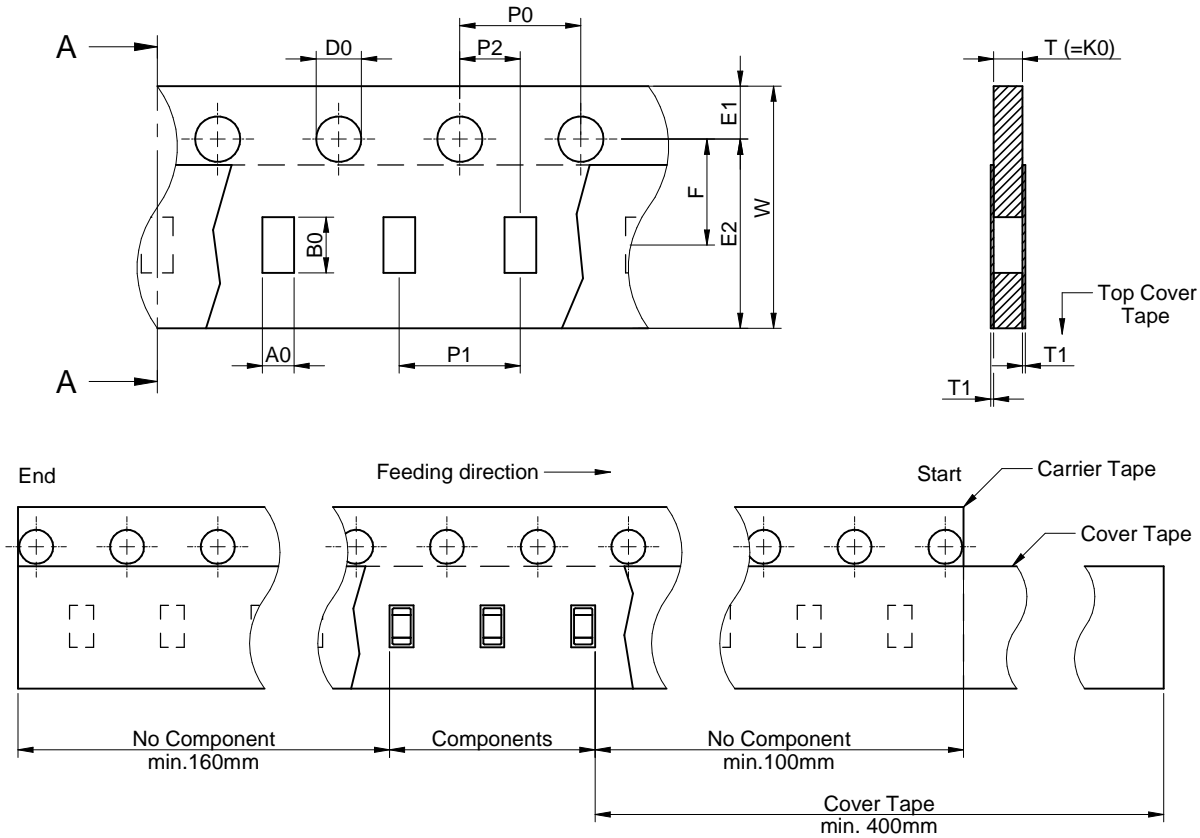



Storage Conditions:


