Typical Insertion Loss:

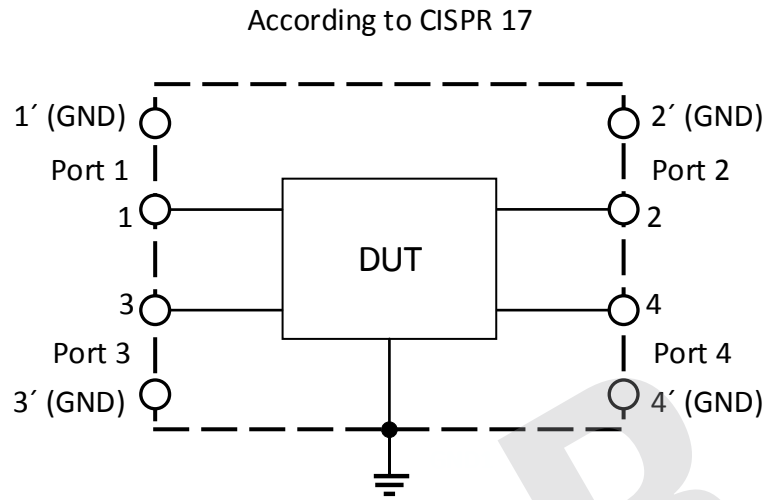


Typical Impedance Characteristics:



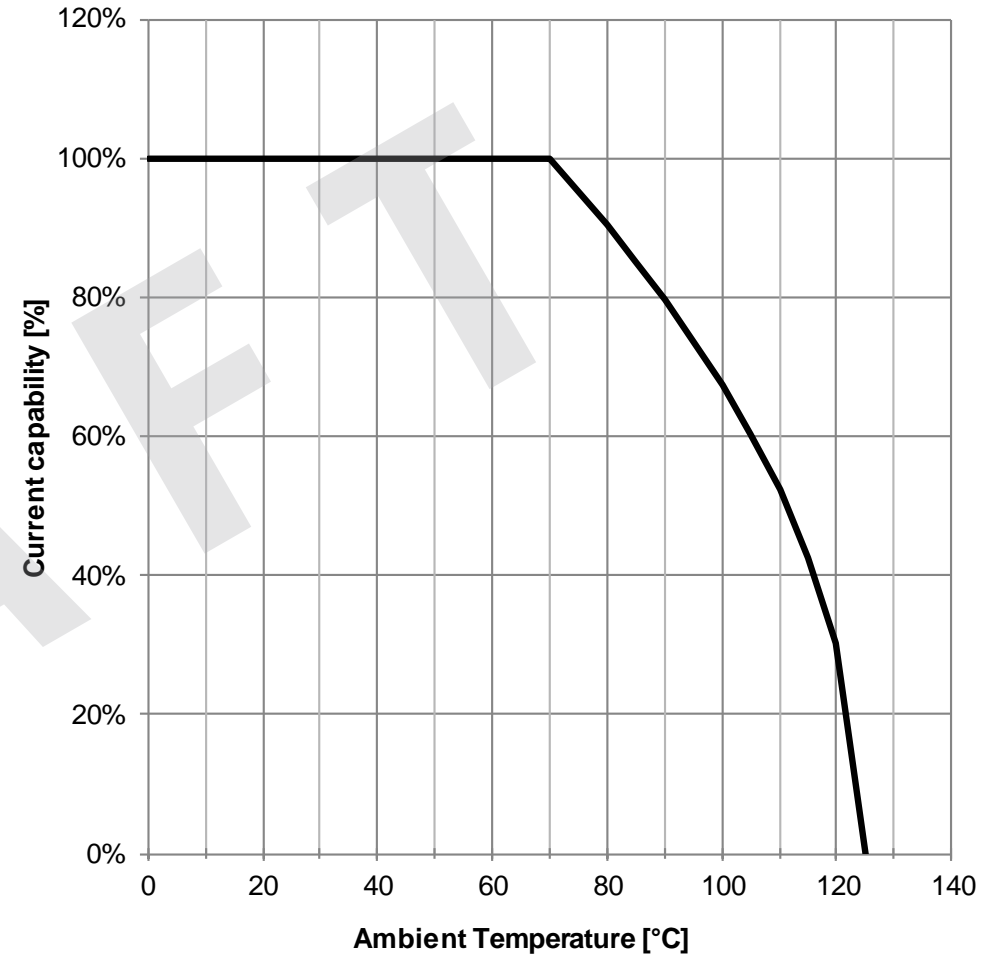

Soldering:




Storage Conditions:


